

Council on Child Abuse Annual Report 2022-2023

Dear Friends,

This past year, the Council on Child Abuse (COCA) continued to respond to the ever growing and evolving needs of students, parents and educators.

During the 2022-2023 school year, COCA provided safety presentations to more than 12,000 children in 601 classrooms at 34 schools. And while this is significant, we continue to receive requests for our powerful prevention message from schools all over the region and the state of Ohio. We would not be able to continue to grow and share our mission without the support of our incredible community.

In July 2023 Erin's Law was enacted in the state of Ohio, requiring schools to implement a child sex abuse prevention program teaching student's pre-K through 12th developmentally appropriate techniques to recognize abuse and how to tell a trusted adult. COCA has been designated as an Erin's Law compliant approved resource by the Ohio Department of Education for Child Sexual Abuse, Dating Violence and Sexual Violence Prevention. The program not only teaches school personnel, parents and guardians the warning signs and but also provides referral and resource information to support kids and families. COCA is proud to deliver a meaningful curriculum in compliance with this law to keep our children safe, compassionate and thriving.

With the support of our board, we remain focused on both advocacy and fundraising. Our annual Reach for the Stars event was held in April to recognize National Child Abuse Prevention Month and was our most successful event to date raising over \$50,000 in support of our mission.

We thank our donors, volunteers and staff who made this year such a success.
